In November 2003, I was the featured soloist for the Woodland Christian Women's Club and Marilyn Plumb was asked to be the featured speaker.

At the Women's club event I was so enthralled with Marilyn's testimony that I approached her with the question, "do you ever speak or demonstrate your product for ladies Bible studies?" I was thrilled when she said "yes."
